3B. Project Description

Micah Ecumenical Ministries is a multi-service agency that provides basic need help, case management, winter shelter, post-hospital respite and job placement, in addition to supportive and rapid re-housing services for Fredericksburg's street homeless. With a relationship-based approach that uniquely focuses on the needs of the chronically homeless, these programs collectively served more than 700 homeless persons in Planning District 16 each year. The Journey Supportive Housing program is one of the housing programs administered by Micah, which strives to end chronic homelessness in the Fredericksburg region. The requested funding sustains a community-wide effort that Micah piloted in 2008 to create housing specifically for the chronic homeless. Journey Supportive Housing has contributed to the decrease in chronic numbers by 53% since 2010 and is now focused on the remaining chronically homeless persons in our community. The requested funding would provide housing for a total of 21 people. Using a community by name, prioritization list, we are able to ensure that those most in need of supportive housing are prioritized for admission. All Journey PSH participants meet HUD's definition of chronic homelessness. Priority is given to those who are on the street, but those in a shelter are considered in accordance with a community prioritization process that considers VI-SPDAT score, disability, episodes and total time homeless to identify those least likely to self-resolve. If no other chronically homeless client can be identified for an available unit, placement will follow the recommended orders of priority for permanent supportive housing beds per Notice CPD-16-11. The Journey PSH program utilizes scattered site apartments in the community and agency owned units to house participating households. In both cases, participants pay no more than 30% of their income and work with case management staff, known as housing stabilization navigators, to maintain their housing, increase their skills/income and improve their self-determination. Apartments are inspected at least monthly for overcrowding, cleanliness, illegal activities, etc. Case management occurs on a regular, ongoing basis to assist participants with barriers to maintaining housing. These areas can include medication management, basic life skills, financial management, substance use treatment, mental health and employment. PSH case management staff partner with other community programs in order to provide needed services to program participants. These partners include mental health services, SSI/SSDI Outreach, Access, and Recovery (SOAR) and employment services. When possible, volunteer mentors and other residential supports complement our core PSH case management team.
