Micah Ministries is a multi-service agency that provides basic need help, case management, winter shelter, post-hospital respite and job placement, in addition to supportive and rapid re-housing services for Fredericksburg's homeless. These programs collectively serve more than 700 homeless persons in Planning District 16 each year. Micah's programs use a relationship-based model with special focus on the chronically homeless. The requested funding sustains a community-wide effort that Micah piloted (originally unfunded) in 2008 to create housing for those whose incomes, backgrounds and credit histories keep them cycling in shelters and on the street for extended periods. Although the project is focused on assisting the remaining chronically homeless persons on the community's by-name list, it seeks a dedicated plus designation to accommodate the unique circumstances of those whose vulnerabilities make them the most frequent users of public systems. The Fredericksburg CoC partnered with the Virginia Housing Alliance and Corporation for Supportive Housing in 2015 to analyze homeless usage of local jails, hospitals, courts and police time. Those identified in the pilot study were prioritized for the units created by this application in FY15. As the program has evolved, we have found many in the frequent user group to spend so much time in hospitals and jails that they can document homelessness for over a decade and still not meet the specific criteria for chronic homelessness. Micah makes units available by leasing scattered site apartments in the community with HUD funding or placing eligible clients in units the agency owns outright. In both cases, participants pay no more than 30% of their income and work with a housing stabilization navigator to maintain their housing, increase their skills/income and improve their self-determination. Apartments are inspected at least monthly for overcrowding, cleanliness, illegal activities, etc. The housing stabilization navigator engages other staff and community resources, as needed, to delve into clients' individual areas of struggle—from medication management and life skills to money management, substance abuse, mental health and work skills. Additional staff support includes a PATH outreach worker, who assists with mental health, and an income navigator, who can help with disability (SOAR) and employment. When possible, volunteer mentors and other residential supports complement our core team. When supportive housing units are not available or a client falls in a less vulnerable category, Micah offers rapid re-housing as an alternative.
