- DDS is closed until further notice

- 3288 consent form must be used with all applications
- Applications can be submitted 120 days prior to exiting institutions

**Community Referral Process**

- Loisann’s Hope House does not receive SOAR referrals from outside agencies. They receive will be taking internal referrals for both Targeted Prevention & Emergency Shelter clients.
- Micah Ministries will be taking on SOAR clients for Micah clients only, beginning with housed clients.
- The Rappahannock Rapidan CSB has 3 staff trained in SOAR and is only taking on internal referrals.
- The Rappahannock Area CSB has secured benefits for all PSH individuals. Staff can complete one SOAR application at a time and is willing to take on referrals from outside agencies.

**First Application**

- All newly trained workers have identified their first SOAR case and will be working to submit those over the next couple of weeks. Workers are to reach out to Lauren for any assistance needed with completing the process.
