Housing Surge Update

- Housing location is gearing up to bring more landlords and units on board to achieve the goal of all households currently in ES housed by the end of the year. Meghann has sent invitations to all providers to join those calls. The financial incentive discussed was to offer to use the funds to pay the security deposit, first month’s rent as well as a sign on bonus equal to one month of rent.
