### Introductions

#### Approval of April 14, 2021 Minutes

- William Sugg was nominated by the CoC Board to fill Susanna Finn's vacant seat. Lisa Crittenden (Loisann's Hope House) moved to approve Will to fill the City's vacant seat on the CoC Board. Christian Zammass (individual) seconded the motion. The motion passed unanimously.

#### Funding and Performance Committee Election

- The CoC Board approved the nomination of Emma Miller-Richards and Clay Mihoulides for election to the Funding and Performance Committee. Kim McClellan (Fredericksburg Area Association of Realtors) motioned to approve the nominations and formally elect Emma and Clay to the Funding and Performance Committee. Juanita Shanks (Failsafe -ERA) seconded the motion. The motion passed unanimously.

### CoC Updates

- **CoC Funding Interest Session (July 26, 10 – 11:30 AM)**
  - The CoC will be hosting an information session for all CoC funding opportunities for members to provide detailed information on funding opportunities and what can be eligible under those applications. Anyone interested in applying for any funding through the CoC is strongly encouraged to attend.
- **Emergency Housing Vouchers**
  - The CoC has been partnering with Central Virginia Housing Coalition (CVHC) to administer the Emergency Housing Vouchers. The CoC has developed a prioritization and referral process and has referred 40 households for vouchers thus far. CVHC is currently working to process the first 28 of those referrals.
- **Homelessness Summit**
  - **The CoC is currently in the planning stages of the Unsheltered Homelessness Summit that is being co-sponsored with the City of Fredericksburg. As more information becomes available on dates and attendance, CoC staff will distribute the information.**
- **Open Positions**
  - The George Washington Regional Commission currently has 2 open positions that benefit the CoC: AmeriCorps VISTA and Program Coordinator. All information on these positions can be found on the GWRC website.
